### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: clear almost colorless crystals.

**Warning!** Harmful if swallowed, inhaled, or absorbed through the skin. Causes eye, skin, and respiratory tract irritation. May cause central nervous system depression. May cause liver damage.

**Target Organs:** Liver, respiratory system, eyes, skin.

### Potential Health Effects

**Eye:** Causes eye irritation. May cause chemical conjunctivitis.

**Skin:** Causes skin irritation. Harmful if absorbed through the skin.

**Ingestion:** Harmful if swallowed. May cause gastrointestinal irritation with nausea, vomiting and diarrhea. May cause liver damage. May cause central nervous system depression.

**Inhalation:** Harmful if inhaled. Causes respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. May cause drowsiness, unconsciousness, and central nervous system depression.

**Chronic:** May cause cancer according to animal studies. Chronic exposure may cause liver damage. Repeated exposure may cause central and peripheral nervous system damage and digestive tract disturbances. Limited evidence of a carcinogenic effect.

## Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

**Ingestion:** Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

**Inhalation:** Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.
